



Our Financial Performance



ANALYSIS

The key metrics considered to evaluate the performance of our nonprofit included board member productivity, program/event efficiency, administrative efficiency, marketing/advertising, membership retention, operational sustainability, fundraising efficiency and donation loyalty.



METHOD

A review of our bylaws, operating practices, committee reports and financial records were conducted and were judged against best practices for nonprofit organizations.



RISK VS. REWARD

Our nonprofit is at risk in the area of leadership and governance as it relates to board members' fiduciary duties. The nonprofit is also at risk when it comes to programming. However, our reward has been greater than our risk. We have established a strategic plan, standard operating procedures, a sponsorship proposal and birthed our first ever Scholarship Program.



CONSIDERATIONS

Board member professional development to include bylaws training, risk management training, financial filing trainings and continuation of annual board member retreats. Board members should be held to their volunteer obligations to ensure that work is equitable. Lastly, ensure that fundraisers have a reasonable expense ratio to lower risk. and increase membership drives.

It has been a pleasure serving as the chapter's 3rd President. The reward has been seeing the chapter grow from five active members meeting at the La Plata, MD police department to a financial membership of approximately 50 at the chapter level, a full executive board of directors and committee seats filled.
